(3) Student application will be reviewed by selection committee, and the following will be considered for admission:

- Ability to work independently and as part of a team
- Enthusiasm for non-traditional approaches to learning
- Eagerness and ability to complete rigorous coursework
- Leadership ability or potential
- Motivation and self-initiative

(4) Other criteria considered by the selection committee include:

- First-generation college students (*The student's parents did not graduate from a 4 year college/university*)
- Students with potential for success in a non-traditional academic setting
- Students open to a strong academic support system
- Students who would benefit from accelerated, rigorous course work (All GECHS courses are honors level.)

(5) Gaston Early College program criteria for continued enrollment

- Student must maintain a cumulative minimum 2.0 grade point average.
- Students must maintain good conduct.
- Students who fail to meet the above criteria will be placed on Academic Probation and subject to transfer to the home high school.

(6) Parent/Legal Guardian should support the school by the following:

- Committing to volunteer and support the student's academic and social success;
- Attending events, and being actively involved as a parent volunteer; and,
- Supporting student-sponsored community service projects.
- Sign a parent commitment form


